

GENERIC NATIONAL SOCIETY AGREEMENT

Memorandum of Understanding
Between
The Institute of Electrical and Electronics Engineers, Incorporated acting through its
Japan Council
and
The Information Processing Society of Japan

To encourage the exchange and dissemination of technical information, and to promote understanding and cooperation among the members of The Information Processing Society of Japan (the "IPSJ") and The Institute of Electrical and Electronics Engineers, Incorporated (the "IEEE"), these organizations have entered into an agreement on the following matters:

1. MISSION OF THE PARTIES

The IEEE is an educational and scientific nonprofit organization. As such, all activities of the IEEE, including all activities in cooperation with the IPSJ contemplated by this Agreement, must be consistent with and must further IEEE's scientific and educational purposes and comply with all laws applicable to IEEE.

The IPSJ is an international organization concerned with electronics, information, communications and related fields with the aim of promotion of scholarly growth, industrial advancement, and cultivation of human resources. As such, all activities of the IPSJ, including all activities in cooperation with the IEEE contemplated by this Agreement, must be consistent with and must further IPSJ's purposes and comply with all laws.

2. JOINT ACTIVITIES

The IEEE and the IPSJ may, subject to agreement on specific items, enter into joint projects, events, and products such as conferences, forums, publications, history, standards, educational materials, awards, etc. Joint activities devoted to preserving and sustaining the environment, teaching math and science to children, improving technology awareness in the general public, and improving the personal and professional lives of the members of both organizations and the profession, will also be explored.

The Technical Societies/Technical Councils of the IEEE and the IPSJ are encouraged to develop joint activities, based on additional individual agreements which will become supplements to this agreement. It is understood that communication will take place with the IEEE Japan Council during the negotiations about these joint IEEE- National Society activities.

The IEEE Japan Council and the IPSJ are encouraged to develop joint activities, based on additional individual agreements that will supplement this document.

3. COORDINATION OF TECHNICAL MEETINGS

To the extent practical, communication will take place when any part of the IEEE proposes to conduct a technical conference or event in Japan, or if the IPSJ intends to hold a conference or event outside Japan.

In addition, access to each organizations schedule of technical conferences and events shall be made available to the other party.

IEEE will provide access to their technical conferences listing through an electronic database on the IEEE website (<http://www.ieee.org/web/conferences/home/index.html>), searchable by several attributes (e.g., location). Contact information for the conference or event chair is available to allow for potential partnering.

The IPSJ will provide access to its list of technical conferences and events through the IPSJ website (<https://www.ipsj.or.jp/english/index.html>). Contact information for the conference or event chair to allow for potential partnering will be provided upon request.

4. STANDARDS INFORMATION

IEEE and the IPSJ may agree to exchange information on their respective Standards activities, and may agree to encourage mutual participation in Standards development.

5. MEMBERSHIP

To implement the cooperation between the IEEE and the IPSJ resulting from this agreement, it is desirable that members of each institution become members of both Institutions by granting special membership dues rates.

For the term of this agreement, a 10% discount of the basic membership dues will be allowed on the IPSJ dues and IEEE basic dues and the IEEE Region 10 Assessment.

This discount applies only to IEEE Higher Grade "full dues" paying joint members. It does not apply to dues already discounted from the full value.

The IEEE Japan Council and the IPSJ each agree to advertise these discounts to their membership.

6. PUBLICITY

Both the IPSJ, and the IEEE, as part of this agreement, pledge to publicize this Agreement aggressively on their WEB site, Correspondence with Members, Publications, Conferences, etc., to encourage all members to participate in the joint cooperative activities of the two organizations.

It is recommended that each party provide a link to the WEB site of the other organization In their WEB site listing of cooperating organizations

It is also recommended that each organization invite the executives of the other organization to key dinners, celebrations and other events at which introductions and publicity for this agreement are provided.

7. REVIEW, AMENDMENT AND TERMINATION

Amendments to the agreement may be proposed at any time, but will not be valid until they have been approved by both the IEEE and the IPSJ.


Other cooperative agreements, which may be made in the future, such as between the IPSJ and a Technical Society/Council of the IEEE, shall be documented in a supplement to this agreement.

The term of this agreement shall be for a duration of three (3) years, from January 2019 to December 2021, subject to termination by either party on three months notice in writing. Renewal is contingent upon approval by both institutions.

This agreement comes into force by the signature of all parties, including the signing of the completed Supplement #1 project program.



Supplement 1 to Memorandum of Understanding between IEEE and IPSJ

This supplement is established to identify the cooperative activities that are agreed to be IEEE and the IPSJ. It is expected that these activities will be completed in 2019.

Activity 1 – IEEE-CS/IPSJ Young Computer Researcher Award

Description of activity – The IPSJ and the IEEE-CS establish a joint award in the field of computing in order to honor the achievements of the recipients, invite other young researchers as potential future recipients, and to raise the visibility of both the IPSJ and the IEEE-CS in the field.
